ELIGIBILITY AND DOCUMENTATION FOR GRANT OF LICENSE:

- (1) The applicant shall be a citizen of Pakistan, meeting the requirement of Operational Standards, knowledge of subject and procedures as mentioned in Appendix-I and Appendix-2 of the Rules.
- (2) The applicant desirous of license to engage or supply seafarer shall submit the following documents, namely:
 - a) Duly filled sealed and signed application Form LRPS with supporting documents as prescribed in the form required by these Rules.
 - b) A certificate from the concerned office of the Income showing National Tax Number of the Company / Registration with the SECP.
 - c) Copy of the Memorandum and Articles of the Association of the Company.
 - d) A certificate from the banker showing the financial position of the Company / last six months Bank Statement.
 - e) Police verification of clearance and evidence of the applicant and staff mentioned in LRPS-I Form.
 - f) Signed agreement on a judicial stamp paper of Rs.100/- as prescribed in Form LRPS-2.
 - g) Bank guarantee of Eight Hundred Twenty-Five Thousand rupees as prescribed in Form LRPS-3.
 - h) Bio-data of the applicant and dealing officials as mentioned in L|RPS Form.
 - i) Copy of the "Agency Contract" between the Principal and Agency authorizing to undertake recruitment and placement services for their vessels.
 - j) Copy of Seafarer Employment Contract (SEA) between the Principal and seafarer.
 - k) Fleet strength alongwith the name, flag, age, type and tonnage of the vessels of the Company for which the Principals have agreed to man the vessels from Pakistan.
 - 1) Wage scale of all categories of Seafarers; and
 - m) Any other documents which may be demanded by the Competent Authority relevant to issuance of license.
