ORDER

Islamabad the July 09, 2025

S.R.O. No. 1220(i)/2025 dated 9th July 2025 - WHEREAS the United Nations Security Council vide its Resolutions Nos. 2653(2022), 2699(2023), 2700(2023) and 2752(2024) has directed to apply travel ban, assets freeze and arms embargo against designated individuals/entities, under Chapter VII of the United Nations Charter;

2. AND WHEREAS through freeze of funds, other financial assets and economic resources of individuals and entities; travel ban and arms embargo, imposed under paragraphs 3, 4, 5, 7, 8 and 09 of the United Nations Security Council resolution 2653(2022), reaffirmed by United Nations Security Council resolution 2752 (2024) adopted under Chapter VII of the United Nations Charter, the United Nations Security Council has decided that all States shall take the following measures, for a period of 1 year (until 18 October 2025), with respect to 2653 Sanctions list (HAITI Sanctions list) against listed individuals/entities:

a) Asset Freeze

Freeze, without delay, for an initial period of one year from the date of adoption of resolution 2752, dated 18 October 2024,

- i. all funds, other financial assets and economic resources, owned or controlled, directly or indirectly, by any individuals or entities listed in the Annex to this order;
- ii. or by any individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them; and
- iii. ensure that neither these nor any other funds, financial assets or economic resources are made available, directly or indirectly, to or for such individuals' or entities' benefit, by nationals or by persons within the territory of the Islamic Republic of Pakistan.

b) Travel Ban

- i. Prevent the entry into or transit through the territory of the Islamic Republic of Pakistan of any individuals designated by the Committee as reflected in the Annex to this order, provided that nothing in the present paragraph shall oblige a State to refuse its own national's entry into its territory;

c) Arms Embargo

- i. for an initial period of one year from the date of adoption of resolution 2752, dated 18 October 2024, take the necessary measures to prevent the direct or indirect supply, sale, or transfer to Haiti, from or through their territories or by their nationals, or using their flag vessels or aircraft, of arms

and related materiel of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment, and spare parts for the aforementioned; and technical assistance, training, financial or other assistance, related to military activities or the provision, maintenance or use of any arms and related materiel. These measures shall not apply to:

- a. the supply, sale, or transfer of arms and related materiel, or provision of related assistance, training, or personnel to or by the UN or a UN authorized mission and to or by a security unit that operates under the command of the Government of Haiti, intended to be used by or in coordination with those entities and intended solely to further the objectives of peace and stability in Haiti;
- b. other supplies, sales, or transfers of arms and related materiel, or provision of related assistance, training, or personnel to Haiti as approved in advance by the Committee established pursuant to resolution 2653 (2022) to further the objectives of peace and stability in Haiti; and
- c. supplies of non-lethal military equipment intended solely for humanitarian or protective use, and related technical assistance or training, when intended to further the objectives of peace and stability in Haiti;

3. AND WHEREAS the UNITED NATIONS (SECURITY COUNCIL) ACT, 1948 (ACT XIV of 1948) enjoins upon the Federal government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

4. AND WHEREAS the Ministry of Foreign Affairs issued S.R.O.s under the UNITED NATIONS (SECURITY COUNCIL) ACT, 1948 (ACT XIV of 1948) to apply certain measures for giving effect to the decisions of the UN Security Council and to reflect changes/amendments and updates made by the 2653 Haiti Sanctions Committee to the list of individuals/entities subject to these measures;

5. AND WHEREAS the Ministry of Foreign Affairs has so far issued 01 S.R.O.s to date in this regard;

6. NOW, THEREFORE, in exercise of powers conferred by Section 2 of the UNITED NATIONS (SECURITY COUNCIL) ACT, 1948 (ACT XIV of 1948), the Federal Government is pleased to order that the Resolution 2752 (2024) be fully implemented, for a period of 1 year (until 18 October 2025), including against individuals/entities in the Annex to this order, reflecting the updates made by the 2653 Haiti Sanctions Committee of the United Nations Security Council till date, shall stand subjected to the measures of assets freeze, travel ban and arms embargo, in accordance with the aforesaid resolutions and as mentioned in paragraph 2 of this order;

7. NOW THEREFORE, the Annex to this order contains addition of 02 entities and 02 individuals specified below, as of 09 July 2025, and will be subject to the sanction's measures in line with paragraph 06 above;

8. NOW THEREFORE, all persons' shall implement the measures stated in paragraph 2 of this order, in accordance with the aforementioned resolutions, against these listed individuals and entities in the Annex to this order, and ensure full implementation of all S.R.O.s issued by the Federal Government, and, whereas any subsequent change to the list of individuals and entities will be communicated through the issuance of S.R.O.s;
